INDIAN PREFERENCE: Preference in filling vacancies is given to qualified Indian candidates in accordance with the Indian Preference Act of 1934 (Title 25, USC, Section 472). Form BIA 4432, a form used to document Indian Preference, must be submitted along with the application, if applicable.

What do Range Interns Do?

- Job-shadow industry professionals with a BIA Agency or Tribal natural resources department performing technical and basic professional duties pertaining to range management work;
- Invasive species management and treatment on trust rangelands as well as projects to address fish and wildlife invasives, causing widespread negative impacts on ecosystems;
- Farm and Rangeland Planning, Improvements and Protection;
- Leasing and Permitting Services;
- Inventory for soil and vegetative surveys.

What is the BIA OTS Pathways Internship Program?

The Pathways Internship Program is designed to RECRUIT, HIRE, TRAIN, DEVELOP, and RETAIN highly qualified Indian/Alaskan Native students pursuing science, technical, engineering, mathematics (STEM) related degrees. The Intern's role is crucial to the various missions of the Department of Interior, BIA and the tribes, in all efforts to provide sound stewardship of natural and cultural resources.

Participant Agreement

The Intern is required to sign a participant agreement prior to selection. The purpose of this Agreement is to establish eligibility criteria for participation in the Internship Program and set forth expectations, responsibilities and opportunities.

Non-Competitive Conversions / Job Placement Services

Student graduates who successfully complete the Pathways Internship Program and meet all position eligibility requirements will be offered job placement opportunities into professional series jobs within the BIA, or Tribe or Tribal enterprise. To be eligible for non-competitive conversion into a full-time position within the BIA, Interns must meet all conversion eligibility requirements, as set forth in the Participant Agreement.
