**Pervious Concrete Technician** - pass written examination with a score of 75% or greater.

**Pervious Concrete Installer** - Pass written examination with a score of 75% or greater and complete Performance Evaluation administered by local sponsoring group. Provide project experience documentation of successful construction of a minimum of 3 projects with a total area exceeding 10,000 square feet.

**Pervious Concrete Craftsman** - Pass written examination with a score of 75% or greater. Possess a current ACI Flatwork Finisher Technician or Craftsman certification at the time of application. Work Experience: Option A - Complete Performance Evaluation and document work experience constructing pervious concrete pavement exceeding 1,500 hours. Option B - Provide work experience constructing pervious concrete pavements exceeding 3,000 hours.

**The performance portion of the exam will not be included at this session.**

Note: A minimum of 8 persons must register or the event may be re-scheduled.
