- a. Budgetary Situation and New Hire in the Administration

 - ✓ Dean of Student resigned during the break. This position needed to be filled. The interim Dean was working with the Dean of Student as an Assistant to the Dean
 - ✓ Sodexho is taking care of the maintenance, in addition to food service

 - \checkmark The University does not have any new debt due to the use of endowment funds
 - \checkmark The new Physical Therapy building is being paid for with cash
 - ✓ The University has refinanced everything
- c. Relocation of OKC Campus in the future

- ✓ Low response. Student experience technical issues
- \checkmark Dr. Smith that LUFS, as a body, make recommendations that do not add costs

 - HigherOne has an agreement with Langston University. In this agreement, Langston University does use credit cards due to high costs
 - Once the contract with HigherOne ends, it will be possible to use a system that accepts credit cards in the business office
