## OKLAHOMA MAIN STREET QUALITY ASSURANCE: 2024

The Oklahoma Main Street Center will measure a quality rating for the local Main Street Programs.

Please remember the **bold-faced** activities below are mandatory for fully designated, active Main Street programs in Oklahoma. Associate levels must attend state trainings. Network levels must attend one state training every two years. The other activities are bonus opportunities to share information with other Oklahoma Main Street programs, provide feedback to the State Office, to attend educational sessions and to support the overall growth and quality of Main Street in Oklahoma.

### QUALITY ASSURANCE ACTIVITIES

**\*ALL TRAININGS, WEBINARS, AND LUNCHEONS MUST BE PRE-APPROVED FOR POINTS TO COUNT.**

Online submission available through the OK Main Street portal. If it's mandatory, it is pre-approved so no need for form.

1. Submission of completed annual agreement on time @ 5 Pts.
2. **Attendance to the National Main Streets Conference @ 25 Pts.** (*New directors & if program didn't attend year before*)
3. Attendance at the Main Street Day at the Capitol @ 5 Pts.
4. **New Town/New Director Training @ 5 points per day** (*New directors required, others optional*)
5. On-time submission of monthly reinvestment reports @ 5 pts. per month
6. **Attendance to the June Program Director / Volunteer Training @ 25 pts.**
7. Attendance to other approved\* conferences, seminars & trainings @ 5 Pts. per day
8. **Attendance to the October Program Director / Volunteer Training @ 25 Pts.**
9. Attendance to approved\* webinars pertaining to Main Street @ 1 Pt. (*Maximum of 20 points*)
10. Attendance to approved\* luncheons pertaining to Main Street @ 2 Pts.
11. Attendance at monthly director zoom meetings & other approved zoom meetings @ 1 Pt.
12. Participation in an approved speaking engagement at meetings/luncheons @ 2 Pts.

Oklahoma Main Street Programs should achieve **at least 125 points** (in National Conference required year) within the period of January through December 2024. Programs that fail to achieve at least 100 points will be placed on inactive status with all services suspended. **If any mandatory training is missed, it MUST be made up, but the makeup training is only worth 5 points per day.**

The top 10 programs earning the most points will receive special recognition at the 2025 Oklahoma Main Street Center Awards Banquet.
