Study Requirements

This national study involves testing students in grades 3-10 in up to five subject areas: English, reading, math, science, and writing, to any or all students in grades 3-10. ACT will assign two additional subject tests to be administered as part of the Spring Study. These assigned subject tests must be completed before the ACT Aspire subject tests in the assessment battery.

Tests may be administered at any time during the testing window of April 1 -18, 2014 and do not need to be administered in one sitting. Subject tests will be administered online, using school-provided desktop computers and laptops, or with paper and pencil. The additional tests assigned for the Spring Study by ACT are computer-based only.

Time Requirements

Testing time requirements will vary by grade level and number of subject tests administered. It will take approximately 30 to 60 minutes for each subject area test; total testing time for each student will depend on the number and type of subject area tests completed.

The additional assigned assessments will take 40 minutes each.

System Requirements

The ACT Aspire assessment system will not require the installation of software on a local PC or Mac. ACT Aspire will support current releases of major operating systems and browsers. A specific list of supported versions will continue to evolve.
