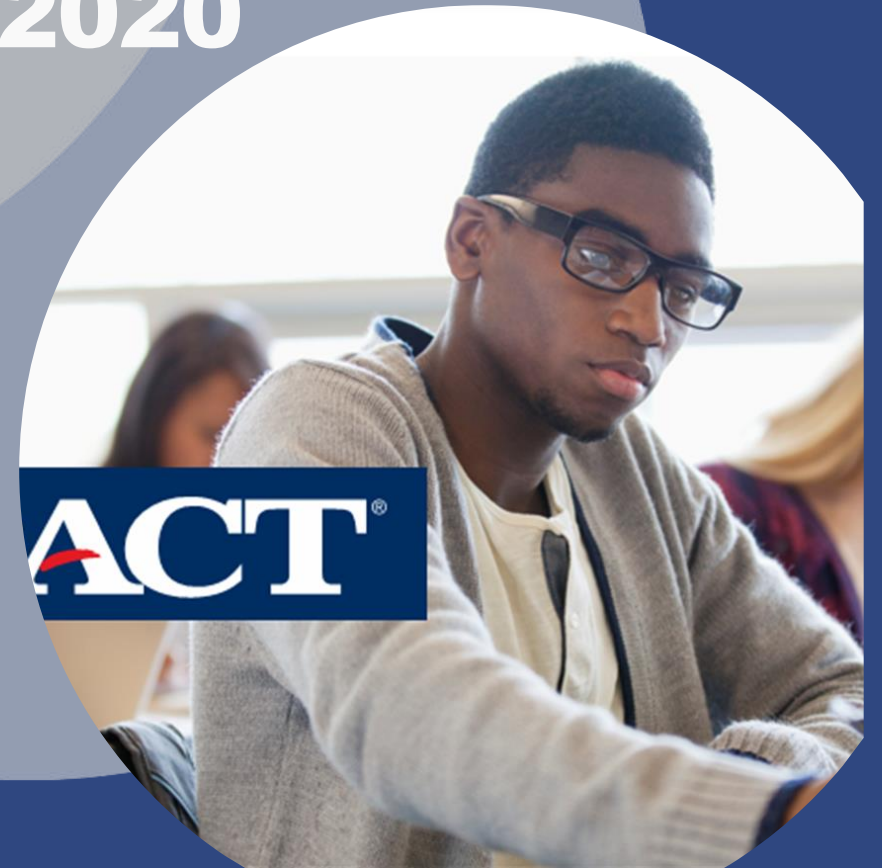

Fall ACT testing options

ACT District Testing Fall 2020 (October 6th and/or October 20th)

The ACT Taken on Paper

- Initial Test Date: October 6, 2020
- Initial Accommodations Testing Window: October 6-9, 2020; October 12-16, 2020
- Makeup Test Date: October 20, 2020
- Makeup Accommodations Testing Window: October 20-23, 2020; October 26, 2020

Flexibility in testing windows to be announced.
Bill will be based on students tested.

\$39 without writing or **\$53** with writing per student (fall)
ACT fee waivers **cannot** be used for District/School Day testing.

Deadline to enroll for fall District Testing is August 14, 2020.

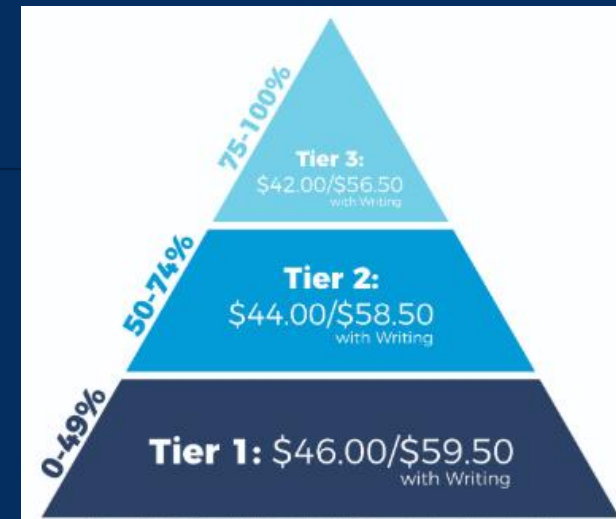

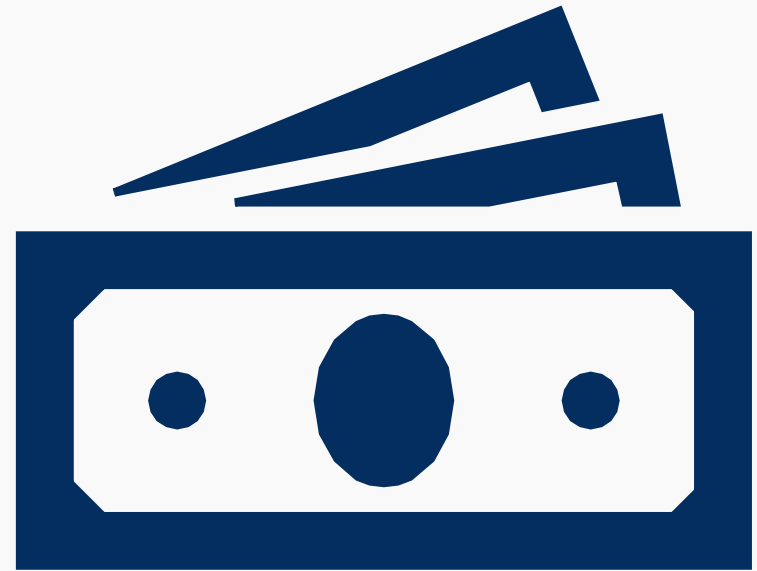
ACT Fee Waiver Expansion

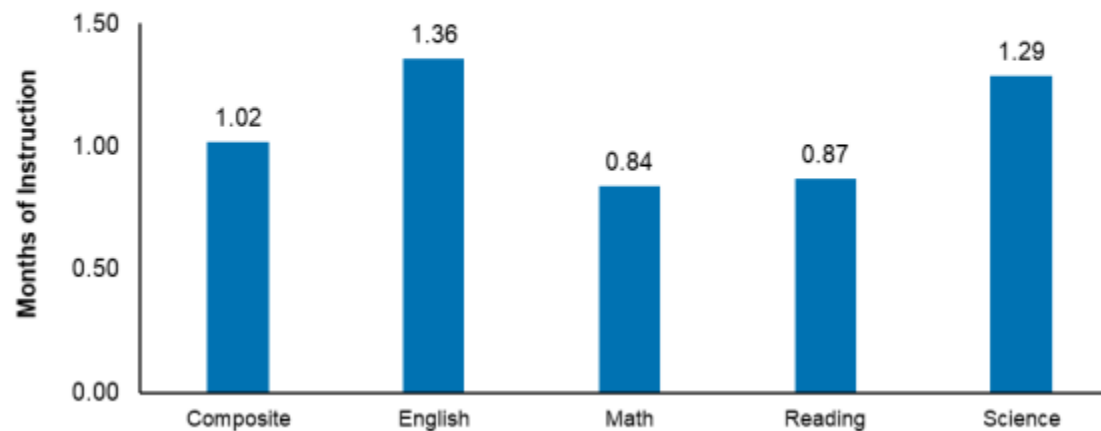
